ON MOTION of Commissioner Flanagan seconded by Commissioner White, to adopt the following resolution:

**WHEREAS,** the Board of Fire Commissioners ("Board") of the Lyndonville Joint Fire District ("District") having previously advertised a Notice to Bidder for the acquisition of one (1) pumper fire apparatus with attendant equipment and appliances and thereafter received a single bid therefor from Churchville Fire Equipment Corporation as Prime Agent for Pierce Manufacturing, Inc. dated July 20, 2023 (the "Churchville/Pierce Bid"); and

**WHEREAS** the Board carefully reviewed the Churchville/Pierce Bid and on July 27, 2023 awarded such bid to Churchville Fire Equipment Corporation as Prime Agent for Piece Manufacturing, Inc.; and

**WHEREAS,** after such Churchville/Pierce Bid was received and awarded a representative of Churchville Fire Equipment advised the Board that, although the Churchville/Pierce Bid included compliance with the engine requirements of the District's Bid Specifications Package dated July 12, 2023, Churchville/Pierce was not able to provide the engine contained in the Churchville/Pierce Bid; and

**WHEREAS**, the Board upon receipt of such representations caused to be prepared and delivered to Churchville Fire Equipment Corporation as Prime Agent for Pierce Manufacturing, Inc. demand correspondence requiring Churchville Fire Equipment Corporation as Prime Agent for Pierce Manufacturing, Inc to stat that it will perform the contract in accordance with its bid in all respects, including full compliance with the engine specified and bid, namely as set forth in the Fire District's Bid Specification Package dated July 12, 2023 including at Paragraphs 58-70 thereof and as otherwise provided, to which no exceptions were taken in the Churchville/Pierce Bid; and

**WHEREAS,** the Board received correspondence on August 3, 2023 from Churchville Fire Equipment Corporation as Prime Agent for Pierce Manufacturing, Inc. that it would not honor its bid dated July 20, 2023, a copy of which correspondence is attached hereto; and

**WHEREAS,** the Board reserved the right in its Bid Specifications Package Dated July 12, 2023 to reject any and all bids within the Board's discretion and that the failure of the bidder to so confirm may result in the cancellation of the contract by the Fire District in its sole discretion.

## NOW THEREFORE, be it

**RESOLVED**, that the prior award to Churchville Fire Equipment Corporation as Prime Agent for Pierce Manufacturing, INC. dated July 20, 2023 is hereby rescinded based on the foregoing recitation of events and facts and the refusal of such bidder to confirm its bid as required; and it is further

Discussion also included: the use of existing specs, providing ample time for other vendors to place bids, and accepting contingencies. A decision to table until the next meeting was made.
